PRACTICAL INFORMATION

The Dushanbe International Investment Forum (the Forum) is a large-scale platform for discussing cooperation opportunities, showcasing the Tajikistan's investment potential, and fostering business ties with foreign partners.

The Dushanbe International Investment Forum 2025 will be held under the motto "Green Investments: Today's Opportunities for Tomorrow's Sustainability" and provides participants with opportunities for dialogue, idea exchange and development of visions and strategies to promote green investments as a key tool for achieving the sustainable future. Particular emphasis will be given to the resources and opportunities of Tajikistan for green investments.

Date and Venue

The Forum will be held on **14–16 October 2025** in **Dushanbe, Republic of Tajikistan**. The opening ceremony and plenary sessions will take place in the **State Complex “Kokhi Vahdat”**, 107 Rudaki Avenue, Dushanbe.

Side events, startup and training sessions, as well as cultural programs will be organized at various venues across Dushanbe.

Entry to the State Complex “Kokhi Vahdat” and other event venues is permitted strictly upon presentation of badges issued by the Forum Secretariat.

Registration

Heads of Government, international and regional organizations, financial institutions, the private sector, and other interested parties are invited to attend the Forum.

Official delegations must register on the Forum website by completing a form with the names and positions of their delegates (official, accompanying, press, security), detailed travel information (route, flight, arrival/departure times), and a personal photo (size 3×4). This information should also be submitted through diplomatic channels by sending the appropriate diplomatic note to secretariat@dushanbeinvest.com and protocol@mfa.tj.

Participation in the Forum is subject to a registration fee equal to 3,000 TJS (approx. 300 USD).

However, for **official delegations invited by the Government of the Republic of Tajikistan**, registration is **free of charge**, with the following hospitality format:

- Prime Minister / UN Secretary-General – 1+5
- Deputy Prime Minister – 1+4
- Minister / Deputy Secretary-General of the UN – 1+3
- Head of international organizations, including international financial institutions – 1+2
- Other heads of official delegations – 1+2

Registration deadline for official delegations: **5 October 2025**.

Visa Support

Participants requiring a visa to enter Tajikistan must obtain one, unless they are citizens of countries with bilateral and multilateral visa-free agreements with Tajikistan.

The Forum Secretariat will provide participants with a Visa Support Letter upon request. In such cases, participants must complete the Questionnaire on the website www.visa.gov.tj. Citizens of certain countries can obtain a visa upon arrival at Dushanbe International Airport.

Citizens of all other countries must obtain a visa from the Embassy or Consular section of the Republic of Tajikistan abroad before their departure.

Participants eligible for visa-free entry or visa-on-arrival, who prefer an electronic visa (e-visa) must apply via www.evisa.tj and pay a fee of 30 USD).

Hospitality

The Government of the Republic of Tajikistan will provide hospitality (accommodation, meals and local transport) based on the level of participation in the following format:

- Prime Minister / UN Secretary-General – 1+3
- Deputy Prime Minister – 1+2
- Minister / Deputy Secretary-General of the UN – 1+1
- Head of international organizations, including international financial institutions – 1
- Other heads of official delegations – 1

International calls, faxes, dry cleaning, mini-bar and other personal services are to be paid by participants.

Invited guests within the official dates of the Forum (14–16 October 2025) will be provided with free accommodation during their official stay in Tajikistan. Any hotel expenses incurred before or after dates of Forum must be covered by the delegation.

Arrival and Departure

- Transfers will be organized from and to **Dushanbe International Airport**.
- High-level guests will be welcomed at VIP and CIP halls of the airport.
- Shuttle buses will connect hotels with the Forum venue.

Security

Security for delegations will be ensured in cooperation with relevant authorities. Delegations arriving with armed security personnel must send a diplomatic notes to the Ministry of Foreign Affairs of Tajikistan in advance for permission.

Media Accreditation

- Local and international media representatives must apply for accreditation via **pressaccreditation@mfa.tj**
- Accreditation deadline: **5 October 2025**.
- Admission to official events is granted only upon presentation of a valid ID and accreditation badge.

Accommodation

- Official delegations will be provided with accommodation according to the established hospitality format.
- Additional participants may book hotels in Dushanbe with the assistance of the Secretariat.

Languages

The working languages of the Forum are **Tajik, English, and Russian**, with simultaneous interpretation provided.

Statements

Heads of official delegations and high-level participants are invited to address the plenary sessions of the Forum.

Speeches are limited to **5 minutes**.

The Organizing Committee encourages contributions that emphasize opportunities for green investments, digital transformation, and sustainable industrial partnerships in Tajikistan and the region.

Format of the Forum

The Forum will bring together government officials, international organizations, financial institutions, investors, entrepreneurs and other stakeholders.

The program includes:

- Opening ceremony and plenary sessions
- Thematic panel sessions and roundtables
- Bilateral and multilateral B2B/B2G meetings
- Exhibition and project presentations
- Cultural events and site visits

The Forum will be held **in-person**, with limited options for online participation.

Cultural Events

The Forum will feature:

- A gala dinner (14 October)
- A cultural program showcasing Tajikistan's heritage, traditions, music, and national cuisine (15 October)
- Excursions to industrial sites and tourist destinations (16 October).

Bilateral Meetings

Meeting rooms for bilateral and multilateral meetings will be available at the Forum venue "Kokhi Vahdat" upon request. Rooms will be allocated based on the order of applications received.

Exhibitions

Participants will have access to investment exhibitions and presentations showcasing priority projects, technologies, and innovative solutions.

Accompanying Persons

Each official delegation will be assigned liaison officers to provide assistance throughout their stay in Tajikistan. The Secretariat will share contact details and names of liaison persons in advance.

Medical Services

First aid will be available at the Forum venue and in the official hotels provided by the organizers.

Currency and Weather

- Official currency: **Tajik Somoni (TJS)**. Exchange services are available at banks, hotels, and the airport.
- Weather in October: daytime temperatures between **+15°C and +25°C**, mild autumn climate.
- Local time: **GMT+5**.

Air Connections

Regular international flights are available to and from Dushanbe International Airport to major cities, including Dubai, Istanbul, Moscow, Saint Petersburg, Almaty, Tashkent, Beijing, Tehran, Delhi, Jeddah, and others.
